



Dear Patient

As you may be aware, Ascot Medical Centre and Green Meadows Surgery will both be co-locating to **Brook House**, a modern, fully refurbished building located at the Heatherwood Hospital site. We are very much looking forward to the move to the new premises expected be in the Spring 2021. We will keep our website up to date on the date for when we will start to provide our services from the new site.

The new premises at Brook House, Heatherwood Hospital, forms part of the wider [Ascot Plan](#) which is to modernise primary and community care for local residents over the coming years and continue to improve on the health outcomes for local people.

Is this a merger of the two Practices?

No, the two practices will be sharing the same premises, Brook House on the Heatherwood Hospital site. However, both practices anticipate closer working arrangements to benefit the population of Ascot through sharing skills and a range of services.

Why are the two practices co-locating?

The general practice services in Ascot need to be updated and future proofed so that we can provide the high quality care that will be needed for the current and increasing population of Ascot.

Will I still see my own GP?

Yes, you will continue to see the GP’s, nurses and other members of the team that you are familiar with.

Reasons for change include:

The co-location is essential to reducing patients’ admission to hospital, improving care co-ordination, providing care closer to patients and increasing self-management with patients and carers. It would not be possible to provide this kind of integrated care in the current Ascot primary care premises.

Brook House is on the Heatherwood Hospital site and can be accessed via the new roundabout on Kings Ride.

How will I obtain updated information on the co-location of the surgery?

Have patients been involved in the planning of the new facility?

The Chair of Ascot Medical Centre PPG has said:

The AMC PPG has been involved from the very early stages of planning, touring the original building and giving comments before plans were finalized and work began.
